2. RELAXATION & RESERVATIONS:

Age relaxation & Reservations will be as per Govt. of India Directives.

3. TENURE OF ENGAGEMENT:

The recruitment will be on Fixed Term Employment (FTE) basis of 4 years, initially for a period of 2 years, which can be further extended to 2 years (i.e. maximum period of 4 years), at discretion of company, based on requirement and satisfactory performance.

4. **REMUNERATION:**

- a) The employee hired on FTE would be placed at minimum of the scale of the grade for which appointed. Exceptional candidates can be considered with increments at the sole discretion of the company.
- b) The salary scale are as per IDA 2007 scales of Govt of India. The selected Candidates will be eligible DA as per Govt announcements (presently 202.3% of basic), Perks @50% of basic, HRA, EL, PF, Medical facilities for self and family and other such statutory benefits available to regular cadre employees as applicable are extra.
- c) An annual increment as per the scale during the tenure shall be admissible on the Basic Pay, subject to satisfactory performance.

5. OTHER BENEFITS

- a) The personnel recruited under FTE will be entitled for 12 days, of casual leave per calendar year, which will be calculated on pro-rata basis for every calendar month of service and 2.5 days of earned leave per month. There will be a provision for encashment of earned leave at the end of the year, as well as at the time of separation.
- b) The tenure based personnel will not be entitled for any allowance or benefits other than those indicate as above in remuneration/Pay scale.

6. SURETY

An amount @ 5% will be deducted at source from the monthly emoluments towards surety amount which on completion of Contract tenure will be paid back to the candidate without any interest. In case the candidate leaves the company or his Fixed Term Employment is terminated before completion of contract tenure, the said surety amount will not be returned back.

7. MEDICAL EXAMINATION

Candidates provisionally selected will have to undergo a Pre-Employment Medical Examination at Instrumentation Limited, Dispensary before joining Instrumentation Limited

9. **GENERAL CONDITIONS:**
